SETTING

The Glen Ivy Center is the perfect setting for spiritual work. The sixty plus acres are nestled in The Cleveland National Forest in a quiet canyon with a creek and 20 acres of organic orchards. There are peaceful paths and gardens for contemplative walks, an herbal labyrinth and historical buildings. The atmosphere enhances personal growth and work.

FORMAT

“The Opening” is designed to maximize your ability to apply spiritual principles in a practical grounded way. It includes presentations of life principles with experiential activities to deepen understanding and apply theory in experience. We include discussions, and various processes. There will be time to participate with the community residents.

SCHEDULE

“The Opening” participants will gather the evening of Sunday, July 11th, at dinner (6 pm). Sessions will end at noon on Sunday, July 18th.

The week is not a normal routine, therefore, be prepared for flexible session times, and a full commitment to the process.

COST

The workshop, accommodations and meals cost \$950. A deposit of \$150 is required upon registration.

CLOTHING

Please bring clothing for outdoor activities as well as indoor activities, a pair of close-toed shoes, a hat and a bathing suit. Dress for comfort.

SUPPLIES

Please bring a pen or pencil and a journal, and personal cosmetic items such as shampoo, sunscreen.

Driving Directions:

The Glen Ivy Center is located between Corona and Lake Elsinore in Southern California, at 25005 Glen Ivy Road, Corona, CA.

From I-15 North, exit at Temescal Canyon Road and turn left at the end of the ramp. At the next stoplight, turn right onto Trilogy Parkway. At the next light, turn left onto Warms Springs Road. The road makes a sharp right and takes you onto Glen Ivy Road. At the stop sign (at the Glen Ivy Hot Springs Spa sign), turn right where you will see a sign for "The Glen Ivy Center Retreats and Conferences". Take the road through the iron gates on the right; bear left at the fork in the road, past our orchards, to the parking lot & the Administration Building.

From I-15 South, exit at Temescal Canyon Road and turn right at the end of the ramp. At the first stoplight, turn right onto Trilogy Parkway. At the next light, turn left onto Warms Springs Road.
